SAMPLE CORRECTIONAL OFFICER TEST

This is a sample test for the Correctional Officer classification. It is patterned after the actual Correctional Officer Written Examination. In order to pass the test, you must correctly answer 58 percent of the questions.

Passing this sample test does not entitle you to participate in the Correctional Officer examination selection process. It does, however, provide you with a good idea of what to expect, should you decide to take the actual Correctional Officer Written Examination.

The following is a breakdown of the test components:

Questions 1 through 15: Spelling, Punctuation and Grammar

Questions 16 through 25: Reading Comprehension

Questions 26 through 40: Basic Math Skills

By reviewing your answer sheet, you should be able to determine the kinds of things you need to study to improve your skills prior to taking the actual Correctional Officer Written Examination. The answers are included in the back of this booklet for your review.

TEST 1.

Writing Correctional Officer Reports Using Correct Spelling, Punctuation and Grammar

If you are hired as a Correctional Officer, you will be required to write complete reports using correct spelling, punctuation and grammar. The following fifteen questions are meant to test your ability to identify errors in spelling, punctuation and grammar in sentences that appear in reports written by Correctional Officers.

Read each sentence and decide whether it has an error in spelling, punctuation, or grammar. Some sentences have no errors. (Do not consider capitalization when checking sentences for errors.) Select an answer for each sentence according to the following instructions.

If the error is in spelling, select Choice (A)

If the error is in grammar, select Choice (C)

If the error is in punctuation, select Choice (B)

NOTE: When There Is An Error In Spelling, Only ONE Letter Is Wrong, Or Is Missing, Or Should Not Be There.

"Punctuation" refers to the marks that make the meaning of sentences clear. The following are punctuation marks:

The period is . The comma is , The semicolon is ;

The colon is: The dash is - The question mark is ?

The apostrophe is ' A set of parentheses is (example) A set of quotation marks is "example"

- In sentence 1, the word "was" is grammatically incorrect. That word should have been "were". Therefore, the error is in grammar. Choice (C) is correct.

TEST 2. -

Reading and Understanding Written Communication Similar to that Used by Correctional Officers

Correctional Officers are required to read and understand written information and to take action based upon what they have read. The next ten questions are designed to test your ability to understand what you read. Each problem consists of a paragraph and four statements based on the paragraph. You are to read each paragraph carefully. After you read the paragraph, examine the related instructions. Choose the one statement, which most accurately reflects what is said in the paragraph. Mark the corresponding letter to that statement on your answer sheet.

Sample Question

Prejudice is a product of unclear thinking. It means forming an opinion in advance, which is not based on knowledge, thought or reason. Some people do not know the rules of clear thinking. Those people make a habit of forming opinions without any facts. They assume that whatever they believe is true, just because they believe it. Their minds tend to be filled with nonsense (prejudiced beliefs) instead of real understanding.

Based only on the information in the paragraph directly above, people who are prejudiced tend to:

- (A) form biased opinions in spite of their understanding of the facts.
- (B) think their own beliefs are factual.
- (C) think clearly if all of the facts are presented to them.
- (D) never make any correct decisions.

Explanation

In the example, the best choice is (**B**), because (**B**) is the only statement fully supported by the paragraph above. The statement, "They assume whatever they believe is true..." is very similar in meaning to, "people who are prejudiced tend to think their own beliefs are factual". The words "true" and "factual" mean almost the same thing.

Choice (A) is incorrect because, according to the reading paragraph, prejudiced people do not know the facts.

Therefore, they do not have an understanding of the facts.

Choice (**C**) is incorrect because the reading paragraph does not indicate whether or not prejudiced people will think clearly once all of the facts are presented to them.

Choice (**D**) is incorrect because the reading paragraph does not state that prejudiced people never make any correct decisions.

TEST 2. - READING AND COMPREHENSION

MULTIPLE CHOICE. CHECK THE CORRECT ANSWER. ONLY ONE ANSWER IS CORRECT.

16. Movies and/or video tapes shall be selected and scheduled for inmate viewing on a quarterly basis. This schedule shall be submitted to the Warden for final approval prior to the beginning of each quarter.

Only movies/videos with an MPAA rating of G, PG or PG-13 may be considered for institutional approval. Regardless of a film's established rating, films glorifying violence, sex, or considered inflammatory to the climate of the institution shall not be scheduled. The CDC Movie Review Committee will review non-rated films.

Based on the information above, choose the one statement, which most accurately reflects or summarizes what is said in the paragraph.

- (A) All films with a rating of G, PG, or PG- 13 may be scheduled for viewing.
- (B) Movies and videotapes are submitted and scheduled for viewing once a month.

- 17. Penal Code Section 2085.5 provides that the Director of the California Department of Corrections (CDC) shall collect court-ordered restitution fines and direct orders of restitution owed by inmates from both inmate wages and trust account deposits regardless of the source of such income.

In accordance with PC Section 2085.5, when an inmate has an outstanding restitution fine or direct order of restitution, the CDC shall deduct 20 percent or the balance owing, whichever is less, of an inmate's wages and trust account deposits, with the exception of Joint Venture Program (JVP) deposits, Family Visit funds, and Temporary Community Leave (TCL) funds. That amount shall be transferred to the State Board of Control (BOC) for deposit in the Crime Victims' Restitution Fund in the State Treasury. In addition, CDC shall deduct and retain from the wages and trust account deposits of an inmate, an administrative fee that totals 10 percent of the deduction, for a total maximum deduction of 22 percent.

18. Wardens and Regional Administrators will prepare and maintain a plan of operations for inmate visiting at their respective institutions and facilities where inmates and parolees reside. The Director's approval is required prior to implementation and before any revision is made to an approved plan. All local visiting procedures must conform to the rules and regulations set forth in this article. Newly arriving inmates will be promptly and verbally informed of local visiting procedures and will be given a written summary of all rules, regulations and procedures governing visiting at the institution/facility in which confined. Additional copies will be readily available for inmates to give or send to their visitors. The written summary will include the visiting schedule, any limitations placed on the frequency of visits or the number of people who may visit an inmate at any one time, guidelines on demeanor, and basic dress standards for visitors.

- (A) All newly arriving inmates are informed of their visitation rights via a written summary of rules only.

There will be a system wide process to establish limits on services or to require prior or concurrent authorization. Medical services will be restricted to those that are medically necessary in order to balance the availability and quality of services that will be available to all inmates. This program will enable physicians and administrators to better understand and monitor the performance of health care delivery. Standardizing services will help health care providers make better medical decisions and reduce ineffective or inappropriate services.

Based on the information above, choose the one statement, which most accurately reflects or summarizes what is said in the paragraph.

- (A) Restricting medical services to those that are medically necessary should balance the availability and quality of services to all inmates.
- (B) The only goal of the new medical package is standardization.
- (C) The basic medical program defines a basic package of dental services that will be available to inmates.
- (**D**) All medical services to be provided require prior authorization.
- 20. Executive Order W-42-93 bans smoking inside all State-owned or leased buildings. This prohibition also applies to State-owned or leased space within buildings shared with others, as well as State prisons and hospitals. This Executive Order does not apply to State-owned housing which serves as the primary residence for State employees, nor does it apply to "prison yards".

In keeping with the objective to provide a healthy, comfortable and productive environment for its employees and prison inmates, and complying with Executive Order W-42-93, all CDC staff and inmates are prohibited from smoking at all times in all CDC buildings. This includes, but is not limited to, all institutions, camps, parole division facilities, the Restitution Community Correctional Center, Community Correctional Reentry Centers, and headquarters. Facilities operated by contract vendors including, but not limited to, public and private Community Correctional Facilities, Work Furlough Centers, Community Prisoner Mother Programs and live-in treatment programs will be addressed separately.

3261.1 Media Access to Facilities.

Media representative access to a department facility or contract facility shall require prior approval of the institution head. Editorial researchers, free-lance writers without an outlet assignment verification, authors of books, film makers, or other persons may be authorized access to a facility only with approval of the institution head and the Assistant Director, Communications.

Facilities, on-duty staff, inmates or records under control of the department shall not be used in conjunction with film making, radio or television programs, or the writing of books, magazine articles or syndicated stories without prior approval of the Director.

Within a facility, media representatives shall be under the direct supervision of the facility or regional public information officer or their designee.

Media representatives shall not enter security housing units, condemned units, the gas chamber, or any area currently affected by an emergency situation without approval of the Director or designate.

In addition to several enumerated rights, other inmates rights, including religious rights, were only to be restricted to the narrowest extent necessary for safety and security. In 1994, the Inmate Bill of Rights was changed allowing staff to restrict inmate rights, including religious rights, so long as the restrictions are "reasonably related to legitimate penological interest." In 1993, Congress enacted the RFRA (Religious Freedom Restoration Act). The RFRA requires government generally to give more deference to an individual's religious beliefs and practices. In 1995, a federal court decision in California determined that RFRA applies to prison inmates.

The Director has delegated this authority to the Regional Administrators of the Institutions Division, and the Assistant Deputy Director, Parole and Community Services Division.

Therefore, the following procedures shall be implemented:

- All inmate/parolee requests for a legal name change shall be reviewed and approved or denied by the Warden/Regional Parole Administrator.
- If circumstances do not exist to warrant approval, the Warden/Regional Parole
 Administrator shall respond to the inmate/parolee in writing outlining the reasons for
 denial, a copy of which shall be placed in the inmate's/parolee's central file.
- If the Warden determines the request should be granted, it shall be forwarded along
 with a cover memo outlining reasons for recommended approval, to his/her
 Institutions Division Regional Administrator. A copy of this memorandum is to be
 placed in the miscellaneous section of the inmate's central file.
- When a court ordered name change is received as a result of departmental approval, the Correctional Case Records Manager shall notify the facility mailroom and visiting room if the offender is incarcerated, or the agent of record if the offender is on parole. The court order shall be filed in the miscellaneous section of the inmate's/parolee's central file, along with the other documents pertaining to the request for a name change.

the name cannot legally be changed without the Director's approval pursuant to
Section 1279.5 of the Code of Civil Procedures. A copy of this letter to the court shall
be placed in the miscellaneous section of the inmate's/parolee's central file and a
copy provided to the inmate/parolee.

Based on the information above, choose the one statement, which most accurately reflects or summarizes what is said in the paragraph.

- (A) The Warden/Regional Parole Administrator may verbally respond to the inmate/parolee if the name change request is denied.
- (B) The Director of Corrections has delegated the authority to approve name changes for inmates/parolees to the Regional Administrators of Institutions Division and the Assistant Deputy Director, Parole and Community Services Division.
- (C) The Warden must verbally notify the court if a court ordered name change lacks departmental approval.

The California Department of Corrections (CDC) shall give written notice at least 45 days prior to release of an inmate from State prison to any person (victim/witness/next of kin/immediate family members), who requests notification in writing, or by CDC Form 1707. In the event that the requestor no longer resides at the address provided, the CDC staff shall make a diligent, good-faith effort to locate the requestor. All telephone calls must be documented including specifics pertaining to the conversation.

"Release" includes a release of a State prisoner or parole violator from the State prison or county jail because time has been served, or a release from State prison or county jail to parole, discharge, release from custody, or transfer to another agency, or an escape from an institution or reentry facility. In the event of an inmate's/parole violator's escape, the requestor shall be notified by the most expedient means possible, either by telephone, through the local law enforcement agency of record, or via telegram.

It is the duty of the requester to keep the CDC informed of his/her current mailing address and telephone number.

TEST 3. -

Basic Math Used in a Correctional Institution

Correctional Officers are expected to take daily counts of the inmates within their work areas. These counts must be accurate and taken quickly because the entire institution is in lockdown mode until counts are cleared. In addition, officers are expected to maintain equipment and supply records, as well as the hours worked, for all inmates under their supervision. The security of the institution is directly affected by an accurate and timely demonstration of these basic math skills.

The Tier 1 count is 64 inmates. The Tier 2 count is 53 inmates. Tier 3 has a total of 48 inmates. Tier 4 has 38 inmates. As a Correctional Officer, you are responsible for Tiers 1 through 4 in your housing unit. What is the total number of inmates in your housing unit?
